Thirty Years and Still Fighting: HRCNF Celebrates the Past and Builds for the Future

This August, Human Rights Council of North Central Florida (HRCNCF), celebrated its board vacancies. Welcome to new HRCNCF 30th birthday since its founding in 1993. HRCNCF began in the early 1990's leading the fight to add LGB discrimination to the Alachua County Human Rights Ordinance, then continuing with the Gainesville HRO. partnership benefits, transgender rights and protections and much more.

Throughout the years we've interviewed local candidates about LGBT+ issues and shared their responses in our newsletter. The Guardian. HRCNCF also informs area residents through panels, forums, and programs about our local LGBT+ history and issues. We've successfully helped lead campaigns to defeat efforts such as "No On One", an infamous anti-trans bathroom initiative. We adopted a section of NW 34th Street as part of Gainesville's Adopt-A-Street program. HRCNCF works collaboratively with other organizations dedicated to ending discrimination based on sexual orientation and other forms of discrimination.

In recent years HRCNCF has lost board members who were HRCNCF officers as well as community leaders. Bob Karp and Craig Lowe passed earlier this year and Terry Fleming in 2020. HRCNCF was left with a need for new people to step up and ensure we would continue as an effective LGBTQ+ organization. Fortunately, when we put out the call for help this summer, community folks answered. We knew we were still in the fight to end discrimination!

Many thanks to Flo Turcotte who recently left the President's office after a long tenure. Congratulations to Tracy Moorman who moved up from Vice President to President. Beyond Presidential: Important State Your Vote-By-Mail Ballot Request and Local Races are on 2024 Ballot

Next year is a presidential election year with a number of important state and local seats and issues on the ballot. Look for candidate questionnaires and more information about amendments from HRCNCF in 2024.

Two state constitutional initiatives that will drive voter turn-out include Adult Personal Use of Marijuana, which has met the voter signature threshold, and the Amendment to Limit Government Interference with Abortion, which is nearly at fifty percent of the signature threshold to make the ballot.

This is the first election cycle that the single-member voting amendment for the Alachua County Commission is in effect.

The 2024 primary election, which includes the School Board elections, is August 20th and the general election is November 5th.

Seats that Alachua County voters will see on their 2024 ballot include:

- United States Senator
- All U.S. Representatives
- State Attorney 8th Circuit
- Public Defender 8th Circuit
- State Senator District 8
- State House Districts 10, 21, 22
- Alachua County Board of County Commission Districts 1, 3 and 5
- Alachua County Constitutional Officers: Clerk of Court, Property Appraiser, Sheriff, Supervisor of Elections, and Tax Collector
- Alachua County School Board District 2 and District 4
- Gainesville City Commission At-Large A, At-Large B, and District 1

Was Cancelled! What To Do Do Now

As a result of new state voting laws passed in 2021, all active vote-by-mail ballot requests in Florida expired at the end of 2022. In order to vote by mail-in ballot in the next election, voters MUST submit a new request.

You can request to vote by mail online, in person, by mail, by telephone, or by fax. Visit the Alachua County Supervisor of Elections website for more information and to sign up to vote by mail: www.votealachua.com/Voters/ Vote-by-Mail.

Voting by mail is secure, efficient, convenient, and inclusive. Alachua County voters don't need postage to return their ballot and you can track the status of your ballot online from when it is mailed to you to when it is counted.

More voters signing up to vote by mail leads to increased turn-out and helps campaigns focus limited resources on getting remaining voters to the polls.

Everyone may not be aware that their mailin ballot request was cancelled, so we need your help to spread the word and to create change in 2024.
